Working as a volunteer is also physically and emotionally demanding. It can require heavy lifting, pulling and pushing, climbing tall ladders, entering extremely small spaces, and facing dangerous circumstances. Responding to fires, accidents and other emergencies requires a volunteer to maintain his or her composure and think clearly in situations most people find very unpleasant or even shocking. Additionally, a volunteer is expected to respond quickly from his or her residence, even if a call comes during the middle of the night or on a holiday. Are you willing and able to satisfy all of these requirements? _____

Prospective members and members of the Golden Gate Fire Protection District fire department may be subjected to security checks and physical examinations. Members may be required to undergo urinalysis or other drug or alcohol testing. Members will also be required to abide by the District's rules and regulations and standard operating guidelines, the orders of superior officers, and directives from the District's Board of Directors. By signing this application you acknowledge the following:

1. That you have carefully read and truthfully responded to the questions set out above;
2. That you voluntarily consent to undergo such security checks, physical examinations and drug or alcohol testing as the District may require;
3. That you agree to abide by the District's rules and regulations and standard operating guidelines, the orders of superior officers, and directives from the Board of Directors;
4. That all gear and equipment provided by the District must be returned upon request and at termination or retirement in good condition, normal wear and tear excepted, and that you may be held financially responsible for damage through carelessness or recklessness; and
5. That you understand that acceptance as a Member does not create any contract of employment or otherwise and that Members do not have the right to receive any compensation or other remuneration for services provided on behalf of the Golden Gate Fire Protection District.
