- **Chief's Report** – (see report posted on website for more details):
  - Planning units for the CWPP in our district have been updated; map will be posted on website
  - 95 calls so far this year, including 2 significant medical calls
  - Issues with ambulance service due to shortage of paramedics
  - Chief negotiated purchase of fuel from Jeffco fueling facility for our vehicles; will save \$1000 annually in current fuel card fees and 50-100 cents per gallon.
- **Discussions**
  - Proposed district fee schedule presented; will be voted on in December after posting on website
  - Potential electrification of fire stations. Advantages of installing solar panels, heat pumps, and battery storage to increase resilience caused by power outages. Ovuworie will research funding opportunities
  - Removal of material from Station 83, a finding of facts. Board determined that Mr. Dave Primmer removed the material without authorization from the Board, and that said material was returned within two days. Lengthy discussion and abundant public comment. All future work on fire stations will require a board vote and a contract process.
  - Future mailing of newsletters (in addition to website postings) will include one in January summarizing previous year accomplishments and one in the summer aimed at firewise education
